Message from the National Chaplain

Happy New Year!

Pope Francis declared 2025 to be a Year of Jubilee. This is a summary of his letter proclaiming the Jubilee, the title of which comes from Romans 5:5, "Hope Does Not Disappoint."

A word of hope

Francis here tells how Paul communicated the message of God's hope to the Christians in Rome. He cites Romans 8:35f, recalling Paul's confidence and strong belief that no person or thing ever separates us from God's love. He then relates hope with another virtue – patience. Paul, he says, frequently speaks of patience in the context of the need for confident trust and perseverance in God's promises. He reminds us that patience is a fruit of the Holy Spirit that sustains and strengthens our hope as a way of life and a virtue.

A journey of hope

Francis anticipates pilgrims to travel to Rome for the Jubilee and visit the various churches and catacombs. Churches on the pilgrimage route as well as in Rome are to be "oases of spirituality" and places of rest for pilgrims. The Sacrament of Confession should be made available.

The Holy Year 2025 looks forward to 2033 and the 2,000th anniversary of Christ's redemptive act.

The Holy Father gives the dates when the Holy Door in each of the four major basilicas in Rome (St. Peter's, St. John Lateran, St. Mary Major, St. Paul Outside the Walls) is to be opened and closed for the Holy Year. He also directs diocesan bishops throughout the world to celebrate a solemn opening of the Holy Year in their cathedrals on Sunday, December 29, 2024. The Holy Year in those churches will conclude on December 28, 2025.

Signs of hope

Although we may feel overwhelmed by the violence and evil in the world, Francis calls upon all to discover hope in our day and the goodness that is in the world. This includes the desires for world peace and for young couples to have children. He also calls upon the Christian community to be a visible sign of hope for all who are going through hardships, in particular prisoners, those sick at home or in hospitals, the young, migrants, and the elderly and the poor.

Appeals for hope

The Jubilee serves to remind all to renew to the call for the fair and equitable distribution of goods, and for adequate funding to eliminate hunger and bring about development in impoverished countries. The pope also calls on the more affluent nations to forgive what is owed them by poor nations, a debt that is impossible to be repaid in full. Francis calls this an act of justice, not of generosity.

The Jubilee Year 2025 will also be the 1,700th anniversary of the Council of Nicaea, which solemnly defined Our Lord's full divinity and established the date for celebrating Easter. Over time, some Christian churches used different factors to determine Easter. Francis notes that since all Christians will celebrate Easter on the same day in 2025 (April 20), the 1,700th anniversary of the Council of Nicaea is a call for work towards Christian unity and a hope for all Christians to celebrate Easter on the same day.

Anchored in hope


In light of the Jubilee, Francis invites us to reflect on the new life Baptism bestows. He notes that baptismal fonts traditionally have eight sides to symbolize Baptism as the 8th Day, the Day of Resurrection, a Day which transcends the normal passage of time.

Martyrs, from the ancient church to contemporary times, provide a most convincing testimony to their hope in eternal life through Baptism.

In Mary, hope discovers its supreme witness. Her sorrows led her to become our Mother of Hope.

As 2031 will mark the 500th anniversary of Our Lady's first apparition at Guadalupe, the pope calls on Marian shrines throughout the world to become special places of welcome for pilgrims. He also calls on pilgrims in Rome for the Holy Year 2025 to visit the city's Marian churches and shrines and ask for Mary's motherly protection.

Hope Does Not Disappoint concludes with the pope's outlook for the Jubilee Year 2025 as one of lasting hope in God and rediscovering trust in the Church and society, in our interpersonal relationships, in international relations, in the task of promoting the dignity of all persons, and in respect for God's gift of creation.



Seeking Internal Auditor

FCSU Financial® is seeking qualified candidates to apply for the Internal Auditor position which will be held from the time of appointment until the next Convention in 2026 when all positions will be up for election.

The applicant must have been a member in good standing of the FCSU for a minimum of five (5) years, a practicing Catholic, a citizen of the US or Canada; cannot sell life insurance or annuities for any other insurer; and cannot be a national officer in any other fraternal or life insurance company, or if selected must resign from that office.

Duties - 7.06 AUDITORS

The Internal Auditors shall consist of four members, one of whom shall be elected by the Convention as Chairman.

A candidate for election by the Convention to the position of Internal Auditor cannot be an employee of the FCSU or its subsidiaries. A FCSU employee, a FCSU retired employee or former employee cannot be appointed as internal auditor.

An Auditor must have an associate or higher accounting degree from an accredited college or equivalent accounting experience.

To the extent that they do not conflict with federal statutes, regulatory provisions or other laws related to the tax-exempt status of the FCSU, as the Internal Auditors of the FCSU and of all subsidiaries of the FCSU they shall furnish management with analyses, appraisals, recommendations, counsel, and information concerning the activities reviewed.

The Internal Auditors shall function under the policies established by the Board of Directors. The policies established shall include the following:

- (a) Audit and review on a test basis the supporting invoices for expenditures including the expense accounts of the Officers.
- (b) Have access at all times to the records of the Officers.
- (c) Submit a signed written report and submit same to the Convention and to Annual Meetings of the Board of Directors.
- (d) Demand and receive all property belonging to the FCSU from National Officers who resign or cease to be an officer or branch officer.
- (e) The duties of the Auditors shall be performed throughout the year as appropriate. Semiannually, the Auditors shall review the activities and financial affairs of the Society.
- (f) The Chairman of Auditors, along with the three Auditors, shall submit recommendations or proposals to the Bylaws Committee in time for their meeting five months prior to the next Convention.
- (g) The Chairman of Auditors shall confer with the outside public accountant to determine what work and/or schedules can be prepared by the FCSU auditors to reduce fees.
- (h) Auditors shall ethically perform their duties and maintain proper levels of confidentiality.
- (i) Internal Auditors shall conduct quarterly audits for compliance and adherence to policies and procedures as outlined in these bylaws or as established by the Board of Directors. The Auditors shall furnish the Executive Committee with written analysis, information, and recommendations of the result of their examination. A detailed written report describing their activities, together with any recommendations, corrective actions or findings shall be distributed to the Board of Directors by the Chairman of Auditors at their Board of Directors meeting.

2025 - Jubilee Year of Hope

Every 25 years the Catholic Church celebrates a Jubilee Year, and 2025 is the Jubilee Year of Hope, taking place now through Jan. 6, 2026, the feast of the Epiphany. Thirty-five million religious pilgrims are expected to visit Rome and the Vatican for this celebration. The home of the Pope, the Vatican is full of cultural significance and houses the largest private collection of art in the world. This will be the 28th jubilee celebrated in the Catholic Church.

Insights and Viewpoints

Nehemiah 8: 2 – 4A, 5 – 6, 8 – 10 I Corinthians 12: 12 – 30 Gospel –Luke 1: 1 – 4; 4: 14 - 21

We begin with the brief introduction by Saint Luke and move to the beginning of Jesus' ministry. We are told that after Jesus was baptized by John, and was tempted in the desert, he returned home. There is something rather touching in that of all the places Jesus could have begun his ministry, such as Jerusalem, he chose to go to his hometown. While Jesus came as Savior of the World, he never denied that he was born to Mary, and grew up in Nazareth where he learned the carpenters trade. He returns to his hometown to his home synagogue and there reads from the scroll of the Prophet Isaiah, and preaches his first sermon.

Jesus chose the sixty-first chapter of the Prophet Isaiah for his reading, and when he completes it he announces that this passage is fulfilled in their hearing. In contemporary terms it could be said that Jesus began his ministry by presenting his mission statement. It's a passage in which we are told that he is anointed to bring good news to the poor, to proclaim liberty to prisoners, give sight to the blind, and set free those who are oppressed.

The rest of Jesus' ministry is his doing just that, and he continues to touch each one of us with his mission. He does so by his personal presence in our lives and in the ministry of the Church, and he does this by using his followers as instruments of his mission. In First Corinthians Saint Paul writes of how this mission of Christ is present within the Church. He speaks

St. Thomas Aquinas' Beatific Vision

January 28th is the Feast of Saint Thomas Aquinas and the 800th anniversary of his birth. It is the culminating feast of a two-year jubilee that began in 2023, with the 700th anniversary of the saint's canonization. In between those two monumental celebrations was the 750th anniversary of the Angelic Doctor's death, elevating the time spanning these milestones to an important period of reflection on the profound influence Saint Thomas Aquinas has had on the life of the Church.

A particularly interesting devotion that took place towards the end of this triple jubilee was a tour of the skull of Saint Thomas, which visited various spots in the United States, including the Dominican House of Studies in Washington, D.C., where Father Thomas Petri, O.P., offered a votive Mass. In his homily, Father Petri said: "We don't believe the body is merely incidental to who we are. St. Thomas was clear. The human person is not just a soul and body. The human soul is such that it needs a body; it's ordered to a body: not only to learn, to remember, to think, and to imagine, but to move, to communicate, to be visible, so to speak, in the world."

Concluding the thought, Father Petri said, "Even now, the soul of St. Thomas retains its ordering to this skull, and this skull is ordered to his soul... and it will rise again on the Last Day...."

Father Petri's meditation is inspired by Aquinas' study and development of Catholic doctrine. The saint's endeavor to explain these complex truths of the faith certainly drew him closer to God throughout his life, which seems confirmed in a mystical experience he had just three months before he died. It happened when he was nearing the end of completing his Summa Theologiae, wherein he sought to condense his most important insights about the faith. It was while celebrating Mass on December 6th, 1223, the Feast of Saint Nicholas, that he received this revelation, considered by some to have been a foretaste of the Beatific Vision. Afterwards, he declared: "I can do no more. The end of my labors has come. Such things have been revealed to me that all that I have written seems to me as so much straw."

Three months later, Aquinas died while on his way to the Second Council of Lyon. Though he did not finish his Summa, it nevertheless stands as one of the monumental achievements in Catholic thought. Before he stopped writing, he offered this description of the Beatific Vision: "The most perfect union with God is the most perfect human happiness and the goal of the whole of the human life, a gift that must be given to us by God."

Saint Thomas shared this insight to inspire all people to pursue the Beatific vision as the greatest end of the human soul, and, as he came to realize, that end is far more glorious than could ever be put into words.

Father Petri's meditation is a reminder of how complete our existence promises to be after the resurrection of the body. The veneration of the skull of Saint Thomas Aquinas that created the occasion for this meditation embraces the sign of contradiction at the heart of the Christian faith. We follow in our Lord's footsteps to take on suffering and even death in a spirit of renunciation of the world to pursue the things of the spirit with faith that God will restore all things in Christ.

of the Church as the "Body of Christ", and goes on to make a beautiful and detailed analogy of the human body with the members of the Church who make up the Body of Christ. The numerous members of the Church are blessed with particular gifts and he gives a list of the individuals present in the church at his time; apostles, prophets, teachers, of their call to do mighty deeds. There is the list of the ministries that are present; healers, assistance, administration, those who speak in tongues and those who interpret. All of these gifts, so different in many ways, serve one purpose to build up the Body of Christ.

Paul is addressing one of the realities that was present in the early Christian communities, and is still present in the church today. The gifts that are meant to unite us together as one Body of Christ, can be the cause of jealousy and division. When we look at those around us and the

particular gifts that are present, as well as the various jobs or ministries people are called to within the church, we can become judgmental and jealous. We know their faults and weaknesses and can become so focused on them that we fail to see their gifts. We can desire to do a certain ministry or job that we become jealous of those who are asked to do thee, while we are not asked.

The lesson in these readings is one that calls us to follow the example of Jesus and go home, or stay home in our own parishes and communities to carry out the mission Jesus has given us. And to do so as Saint Paul teaches us by looking at our fellow Christians as brothers and sisters who are gifted, as we are, and to use these gifts together so as to truly be the unites as the Body of Christ.

Beautiful Children of Tanzania

I am walking down a red dirt road through a remote village near Arusha, Tanzania with my fellow missionaries. Various sights and smells perk my interest as I see banana and papaya trees surrounding me. Abruptly we come to a stop but to my surprise I am standing in front of three beat-up wooden walls with a curtain as the door and metal plates as the ceiling. Soon after, a family of six, appears from behind the curtain and greets us all in a foreign language that we are unable to understand. Our interpreter steps forward and begins explaining our mission and our reason for being there. We then provide the family with numerous supplies (water, flour, milk) necessary for their survival. The grateful expression on their faces is unforgettable. Later that day, the family and others in the village teach us how to prepare and cook meals traditional to their culture, and do the laundry by hand. After staying in this foreign but warm place for a few hours, we then move on to other settlements to deliver more food.



Contemplating the hardships such as scarce resources or limited shelter that I had seen that day, I could finally understand and realize how deprived and impoverished some people are around the world. Throughout this Mission trip, I developed a love and passion for helping others in need. Simply because I was overcome by a feeling of joy knowing that I am enhancing someone's life.

During my three weeks in Tanzania, I passionately cared for babies and children at orphanage called Upendo (meaning "Love" in Swahili). In the afternoon we volunteered at street home called Msamaria located in foothills of Mount Kilimanjaro. We served as "big" brothers and sisters to the dozens of children who were abandoned in their

Despite our obvious differences I felt a connection with those kids. Most of the younger children were unable to speak English, which made it difficult to communicate. Nevertheless, we both found ways to communicate. I used my limited Swahili language which consisted of numbers and greeting. Not only was I able to form closer relationships with some children and adults, but I also adapted some of their beautiful culture and values. This was the most rewarding part because I learned appreciation and showed my love to these children by respecting and being a part of their culture.

This Mission Trip gave me an opportunity to experience the truths and wonders of the world through my own eyes and actions. I came back home knowing that not only was I able to help those in need in Tanzania, but also grow as a person. I saw and lived what most others never get to experience in real life.

Some people asked me "Why would you ever want to go to Africa?" I can proudly answer that I did it because I simply wanted to spread my love and help others. I am already looking forward to my next mission trip to El Salvador this February. I will be assisting professionals who will be providing medical services to residents.







Reverend Ronald Kurzawa Branch 743 Sterling Hts, MI

Reverend Ronald Kurzawa was the eldest child born to Sigmund and Helen



Fr. Kurzawa was raised on the East side of Detroit in SS Cyril and Methodius Parish. He entered Sacred Heart Seminary in 1953 and also completed High School there. He attended college at St. Mary's, Orchard Lake and Graduate School in Theology at St. John Provincial Seminary in Plymouth, MI.

He was ordained into the priesthood on June 6, 1964 at the Cathedral of the Most Blessed Sacrament by John Cardinal Dearden. Following his ordination, Fr. Kurzawa served as an Associate Pastor at St. Cunegunda Parish in Detroit from 1964 to 1968 and then St. Bartholomew Parish in Detroit from 1968 to 1973. He became Pastor of St. Clement of Rome Parish in Romeo in 1973 until 1982 when he became Pastor of Precious Blood Parish in Detroit. In 1992 he was given the assignment as Pastor of St. Margaret of Scotland Parish in St. Clair Shores. In 2002, he was named Pastor of St. Aiden Parish in Livonia where he served until his retirement and granted senior priest status in 2008.

In 1973, Fr. Kurzawa received a graduate degree in Liturgical Theology from the University of Notre Dame. As a result, he served in several consultative roles for the Archdiocese in the area of Liturgy. He also served at various times as adjunct professor of Liturgy at SS. Cyril and Methodius Seminary, Orchard

Lake and Sacred Heart Seminary, Detroit. He was also the coordinator of the distribution of Communion at the Pontiac Silverdome on the occasion of the visit of Pope John Paul II to Detroit in September 1987.

In addition to parish roles, he served as Priest Chair to the Archdiocese Development Fund, member of the Archdiocesan Council of Vicars, member of the Archdiocesan Pastoral Council, member of the Presbyterial Council and the Worship Commission of the Archdiocese of Detroit.

In 1990, Fr. Kurzawa was granted the Farwell Award and spent a sabbatical studying at the North American College in Rome.

Fr. Kurzawa has given lectures, workshops and a number of retreats. In retirement, he served the Dominican Sisters of Peace in Oxford along with several Archdiocesan Parishes, most notably St. Hubert Parish in Harrison Township.

News from Slovakia - Správy zo Slovenska

Lecture on Slovak Culture in Washington Attracts Surprise Guest

On the eve of the 2024 U.S. presidential election, Nov. 4, an audience at the Slovak Embassy in Washington, D.C. enjoyed a delightful presentation of Slovak cultural heritage as well as an unexpected visit by a high-level government official.

A lecture and presentation entitled, "Slovak Intangible Cultural Heritage: Music, Traditions and Instruments," was led by Prof. Juraj Hamar. Prof. Hamar is a recognized musicologist, ethnologist, and expert on traditional Slovak folk music. Currently head of the Department of Aesthetics at Comenius University in Bratislava, he is also general director of the Slovak Folk Art Institute (SL'UK), where his scientific work focuses on the research of Slovak folk songs and musical instruments. Prof. Hamar was in Washington after doing a similar presentation the day prior at the University of Pittsburgh Slovak Heritage Festival.

Prof. Hamar is an enthusiastic performer of music on folk instruments, and he regularly performs at concerts and cultural events both in Slovakia and abroad. For this lecture he focused on an overview of the Representative List of Intangible Heritage that is compiled by UNESCO (United Nations Educational, Scientific and Cultural Organization). Countries submit a list of items for the List which are reviewed for inclusion. The purpose of the list is to promote preservation of cultural treasures thus contributing to international cooperation and understanding. Prof. Hamar focused on seven Slovak items that have been approved for the List, and he presented videos or personally demonstrated the items (https://www.unesconadosah.sk/nehmotne-dedicstvo-unesco).

These included:

- Fujara and fujara music
- Bagpipes and bagpipe culture
- Horehronie polyphonic singing
- Tinkering

- (village of) Terchová music
- Traditional puppetry in Slovakia
- Blue print fabric process
- Falconry

In addition to performing on the fujara, flutes, and bagpipe (one that is a little different than what you are used to from Irish/British culture), Prof. Hamar turned to an amusing demonstration of Slovak puppetry, including the famous 'Gašparko,' who accompanied him from Slovakia. The audience was treated to an informative lecture and really a tour-de-force of Slovak traditional culture.

As the audience assembled for the performance, they were a bit surprised as in walked the Chief

Justice of the Supreme Court of the U.S., John G. Roberts, with his wife Jane, who sat down in the front row. The Chief Justice had received an invitation from the Slovak Embassy and decided to accept it, perhaps seeking a slight break from the focus on the imminent presidential election. As is generally known, the Chief Justice has Slovak ancestors on his mother's side that came from the Spiš region. Prof. Hamar even performed a song from the region for the Chief Justice.

After the presentation, Amb. Radovan Javorčík hosted a reception for the attendees, many of whom interacted casually with the Chief Justice. It is nice to know that the evening prior to a momentous presidential election, the head of one of the three branches of the federal government (the Chief Justice) chose to spend his time with the Slovaks and Slovak culture.

V predvečer prezidentských volieb v USA v roku 2024, 4. novembra, sa publikum na slovenskom veľvyslanectve vo Washingtone, D.C. tešilo z príjemnej prezentácie slovenského kultúrneho dedičstva, ako aj z nečakanej návštevy vysokého vládneho predstaviteľa.

Prednášku a prezentáciu s názvom "Slovenské nehmotné kultúrne dedičstvo: hudba, tradície a nástroje" viedol prof. Juraj Hamar. Prof. Hamar je uznávaný muzikológ, etnológ a odborník na tradičnú slovenskú ľudovú hudbu. V súčasnosti je vedúcim Katedry estetiky na Univerzite Komenského v Bratislave, zároveň je generálnym riaditeľom Slovenského ľudového umeleckého ústavu (SĽUK), kde sa vo vedeckej práci zameriava na výskum slovenskej ľudovej piesne a hudobných nástrojov. Prof. Hamar bol vo Washingtone deň po podobnej prezentácii na Slovak Heritage Festival v Pittsburskej Universite.

Prof. Hamar je zanieteným interpretom hudby na ľudových nástrojoch a pravidelne vystupuje na koncertoch a kultúrnych podujatiach na Slovensku i v zahraničí. V rámci tejto prednášky sa zameral na prehľad Reprezentatívneho zoznamu nehmotného dedičstva, ktorý zostavuje UNESCO (Organizácia Spojených národov pre vzdelávanie, vedu a kultúru). Krajiny predkladajú zoznam položiek do zoznamu, ktoré sa posudzujú na zaradenie. Účelom tohto zoznamu je podporovať zachovanie kultúrneho bohatstva a tým prispieť k medzinárodnej spolupráci a porozumeniu. Prof. Hamar sa zameral na











sedem slovenských položiek, ktoré boli schválené do Zoznamu, a položky prezentoval alebo osobne predviedol (https://www.unesconadosah.sk/nehmotne-dedicstvo-unesco).

Okrem hrania na fujare, píšťalách a gajdách (trochu iných, než na aké ste zvyknutí z írskej/britskej kultúry), sa prof. Hamar venoval zábavnej ukážke slovenského bábkarstva, vrátane slávneho Gašparka, ", ktorý ho sprevádzal zo Slovenska. Poslucháčov čakala poučná prednáška a naozajstná prehliadka slovenskej tradičnej kultúry.

Keď sa diváci zhromaždili na vystúpenie, boli trochu prekvapení, keď kráčal predseda Najvyššieho súdu USA John G. Roberts so svojou manželkou Jane, ktorí sedeli v prvom rade. Predseda senátu dostal pozvanie od slovenského veľvyslanectva a rozhodol sa ho prijať, možno si chcel trochu oddýchnuť od sústredenia sa na blížiace sa prezidentské voľby. Ako je všeobecne známe, predseda Najvyššieho súdu má z matkinej strany slovenských predkov, ktorí pochádzali zo Spiša. Prof. Hamar dokonca predniesol pre predsedu senátu pieseň z regiónu.

Po prezentácii Amb. Radovan Javorčík usporiadal recepciu pre prítomných, z ktorých mnohí nezáväzne komunikovali s predsedom senátu. Je príjemné vedieť, že večer pred významnými prezidentskými voľbami sa šéf jednej z troch zložiek federálnej vlády (predseda súdu) vybral stráviť čas so Slovákmi a slovenskou kultúrou.
