

#### Message from the National Chaplain

INTERNATIONAL DAY OF PRAYER AND AWARENESS AGAINST HUMAN TRAFFICKING

The Pontifical Council for Justice and Peace and the International Union of Superiors General has designated February 8 as an annual day of prayer and awareness against human trafficking. This day was chosen because it is the feast of Saint Josephine Bakhita. Josephine, born around 1869 in Sudan, was kidnapped as a child and sold into slavery to a number of owners. She eventually was purchased by the Italian Consul, brought to Italy, and sent to live with a religious community of women. Josephine was formally introduced to the Faith, baptized, and eventually granted her freedom. She joined the Canossian Daughters of Charity and served her fellow sisters as cook and seamstress. She died in 1947 and was canonized in 2000.

#### SS. Cyril and Methodius February Appeal

The Saints Cyril and Methodius Appeal is in its 47th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. Today, the Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in January to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, and previous donors.

As of February 1, 75 donors have given \$5,055.00 for the 2025 Appeal. Among the 19 donations received from Catholic Slovak Fraternal Branches and Districts, Branch 40, Branch 45, Branch 112, Branch 166, Branch 320, Branch 731, Branch 743, Branch 746, Branch 857, and District 14 of the FCSU have donated a combined total of \$825. Donations have also been received from 14 clergy and religious and 42 individuals. On behalf of the Pontifical College, thank you for your continued generosity and support.


As I mentioned above, we are in the process of updating our cybersecurity protection levels and need your help.

#### **February Reflection**

Having celebrated and concluded the Christmas season, I remain impressed by the beauty of the holy names—Jesus, Mary, Joseph. Thus, I chose this favorite hymn in honor of The Holy Family.

The name "Jesus" means "God saves." The child born of the Virgin Mary is called Jesus, "for He will save His people from their sins" (Mt 1:21). "There is no other name under heaven given among men by which we must be saved" (Acts 4:12).

God chose for the mother of His Son "a virgin betrothed to a man whose name was Joseph, of the house of David, and the virgin's name was Mary" (Lk. 1:27). Here we witness how Mary was predestined and "chosen" by name to mother God's Son. God chooses those who are considered powerless and weak to prove His faithfulness to His promises. #### **Insights and Viewpoints**

Luke 6:17, 20-26, Demetrius R. Dumm, O.S.B

It is instructive to compare Luke's Beatitudes with those of Matthew (5:2-11). Luke offers just four Beatitudes while Matthew gives us eight. But the four that Luke shares with Matthew are considered the oldest version and contain the essential teaching. Luke also adds four Woes, not found in Matthew, and intended to re-enforce, by contrast, the message of the previous Beatitudes.

The most important word in all the Beatitudes is the subject of the first one, namely, the "poor." This English word, suggesting economic destitution, does not at all capture the full meaning of the Hebrew word from which it is ultimately derived. In that fuller sense, the poor are the "afflicted ones" or, more specifically, the "powerless ones." This often includes the economically destitute but it includes also those who recognize their radical poverty when it comes to the matter of final salvation. In the gospel, the poor stand in contrast to the Scribes and

Pharisees who, though themselves far from materially rich, were so "full of themselves" and so smug about salvation that they effectively closed themselves to the free gift of the Kingdom.

In essence, therefore, God gives salvation to those humble ones who know how powerless they really are in spiritual matters and who are ready to turn humbly to God who is more than willing to give them the Kingdom. The "hungry" and the "weeping" and the "persecuted" are variations on the poor ones. The hungry know that only God can satisfy their needs and do not try to place that burden on any merely human creature. The weeping know that God's command to love often leads to grieving...and who love nonetheless. The persecuted, or ridiculed ones, gladly embrace the "foolish" wisdom of unselfish service because they realize that God's gift is only for the generous ones.

#### LIGHT ONE CANDLE

#### Fra Angelico's Paintings as Prayer

February 18th is the Feast of Blessed Fra Angelico, who was a Dominican friar and painter of the early Italian Renaissance. When Pope John Paul II beatified him in 1982, he was asked about Fra Angelico's miracles and simply pointed to his paintings and said, "These are his miracles."

Born in Tuscany around 1395, Fra Angelico's initial training as an artist was in the creation of illuminated manuscripts, and he went on to paint frescoes and other works for churches and religious houses throughout Italy. Scripture was his inspiration, and he always prayed for God's blessings on his work and viewed the act of painting as a prayer in and of itself.

Two years after beatifying Fra Angelico, John Paul II declared him patron of Catholic artists. In one of the beautiful and laudatory statements he made about Fra Angelico, John Paul II said, "Angelico was reported to say, 'He who does Christ's work must stay with Christ always.' This motto earned him the epithet 'Blessed Angelico,' because of the perfect integrity of his life and the almost divine beauty of the images he painted, to a superlative extent those of the Blessed Virgin Mary."

In the spring of 2024, the Uffizi Gallery, a prominent museum in the heart of Florence, presented a reunification of Fra Angelico's Glorification of Mary with the original predella he painted to accompany it. Created sometime between 1431 and 1435 for the hospital church of Santa Maria Nuova in Florence, the Glorification of Mary depicts our Blessed Mother assumed into heaven and enthroned beside Christ the Redeemer. The Predella, which is a separate panel beneath the main painting, consists of two compartments depicting the Marriage and Funeral of the Virgin.

The Glorification was separated from its predella in the 17th century and eventually reunited at the Uffizi only to be separated again during World War II and moved around to secret locations to protect it from bombings and raids by the Nazis. After the war, the main panel returned to the Uffizi, while its predella wound up in a different museum in Florence. It wasn't until last year, when the predella finally returned to the Uffizi, that the work could be displayed again as Fra Angelico originally intended.

In his authoritative book on Italian art entitled Lives of the Artists, 16th century historian Giorgio Vasari called Fra Angelico, "a rare and perfect talent," adding, "It is impossible to bestow too much praise on this holy father, who was so humble and modest in all that he did and said and whose pictures were painted with such facility and piety."

This statement about the character of Fra Angelico has certainly heightened interest in the intent underpinning his Glorification and the predella he created to accompany it, and the Uffizi has rightly celebrated this reunification. Those who visit the work now receive a fuller glimpse of his vision in this beautiful tribute to the life of our Blessed Mother and the exalted status she occupies in our faith. In his life and work, Fra Angelico demonstrates how the arts can work in service to the faith to illuminate the figures, stories, and principles at the heart of Scripture. May Fra Angelico intercede for all artists to draw closer to Christ so their work can reveal truth to all people and inspire us to see the beauty of creation and the faith given to us to discover God's love.

The seemingly benign appearance of these well-known Beatitudes conceal a very harsh judgment on many of the attitudes of the secular culture in which we live and by which we are probably influenced far more than we realize. This secular culture (and our natural instincts) lead us to place a very high premium on control. A metaphor for this in our contemporary world is the remote control for our TVs. There is a pleasing sense of power in being able to "zap" advertisements and people on the screen with whom we disagree.

This tendency could be relatively harmless except when we allow it to influence our relationship with God and our attitude toward other people. An excessive yearning for control is clearly a prideful attitude and it is pride, more than anything else, that blocks our access to the free gift of salvation. It can also

destroy the delicate fabric of our loving relationship with other people.

The opposite of our passion for control is our willingness to love to the point of vulnerability. Machismo is unhealthy because it is so out of touch with reality. We are living in a dangerous illusion when we think that we must always be in control. The fact is that we do not control the most important realities in life, such as love, happiness and life itself. These are wonderful gifts and we should be happy to accept them as such. When we try to seize them, they inevitably slip through our fingers.

We need to understand the true role of power. It can be very useful but it must always be guided by love. When that happens, we can also let go of it, when the time comes, and thus be ready for the exquisite gift of God's Kingdom.

# Reconnect with Your Slovak Heritage and Homeland

#### **Seeking Internal Auditor**

FCSU Financial® is seeking qualified candidates to apply for the Internal Auditor position which will be held from the time of appointment until the next Convention in 2026 when all positions will be up for election.

The applicant must have been a member in good standing of the FCSU for a minimum of five (5) years, a practicing Catholic, a citizen of the US or Canada; cannot sell life insurance or annuities for any other insurer; and cannot be a national officer in any other fraternal or life insurance company, or if selected must resign from that office.

#### **Duties - 7.06 AUDITORS**

The Internal Auditors shall consist of four members, one of whom shall be elected by the Convention as Chairman.

A candidate for election by the Convention to the position of Internal Auditor cannot be an employee of the FCSU or its subsidiaries. An FCSU employee, an FCSU retired employee or former employee cannot be appointed as internal auditor

An Auditor must have an associate or higher accounting degree from an accredited college or equivalent accounting experience.

To the extent that they do not conflict with federal statutes, regulatory provisions or other laws related to the tax-exempt status of the FCSU, as the Internal Auditors of the FCSU and of all subsidiaries of the FCSU they shall furnish management with analyses, appraisals, recommendations, counsel, and information concerning the activities reviewed.

The Internal Auditors shall function under the policies established by the Board of Directors. The policies established shall include the following:

- (a) Audit and review on a test basis the supporting invoices for expenditures including the expense accounts of the Officers.
- (b) Have access at all times to the records of the Officers.
- (c) Submit a signed written report and submit same to the Convention and to Annual Meetings of the Board of Directors.
- (d) Demand and receive all property belonging to the FCSU from National Officers who resign or cease to be an officer or branch officer.
- (e) The duties of the Auditors shall be performed throughout the year as appropriate. Semiannually, the Auditors shall review the activities and financial affairs of the Society.
- (f) The Chairman of Auditors, along with the three Auditors, shall submit recommendations or proposals to the Bylaws Committee in time for their meeting five months prior to the next Convention.
- (g) The Chairman of Auditors shall confer with the outside public accountant to determine what work and/or schedules can be prepared by the FCSU auditors to reduce fees.
- (h) Auditors shall ethically perform their duties and maintain proper levels of confidentiality.
- (i) Internal Auditors shall conduct quarterly audits for compliance and adherence to policies and procedures as outlined in these bylaws or as established by the Board of Directors. The Auditors shall furnish the Executive Committee with written analysis, information, and recommendations of the result of their examination. A detailed written report describing their activities, together with any recommendations, corrective actions or findings shall be distributed to the Board of Directors by the Chairman of Auditors at their Board of Directors meeting.



"I mailed my check to the gas company two months ago to pay the \$45 bill. Today, the gas company sent me a bill stating I hadn't paid last month's bill. So, they charged me again for last month's bill plus this month's bill, plus a late payment fee of \$25. I just checked my bank statement, and I noticed that somehow the \$45 check I had written was altered to read \$4,500 and someone cashed it."

# **Be on the Lookout for Check Washing Scams**

Check washing scams like the example above are on the rise, with the U.S. Postal Inspection Service reporting a 161% increase nationwide in recent years. Criminals steal checks from mailboxes or postal facilities, erase the original details using household chemicals, and replace them with their own name and a higher amount. They then cash or deposit the counterfeit checks, leaving victims with significant financial losses.

#### **How to Protect Yourself:**

- 1. GO DIGITAL: Set up automatic payments through your bank to eliminate the need for mailing checks.
- 2. USE SECURITY ENVELOPES: Avoid using envelopes that say "payment enclosed." Instead, opt for opaque security envelopes.
- 3. WRITE SMART: Gel pens are harder to erase, but counterfeiters are increasingly sophisticated—consider minimizing check use altogether.
- 4. STAY VIGILANT: Check your bank statements daily for unauthorized transactions and report them immediately.
- 5. SECURE YOUR MAIL: Never leave outgoing mail in your outdoor mailbox.

If you suspect check fraud contact your bank immediately. Take steps to safeguard your finances and help protect yourself from becoming a victim of check washing.

# FRANTastic Cuisine BY FRAN STREKAL

#### **CHICKEN PAPRIKASH**

#### YOU WILL NEED

1 large cast iron skillet or Dutch oven
3lbs thawed boneless skinless chicken thighs
& breasts sliced & seasoned with paprika
2 cups chicken broth
2 medium onions sliced and diced
2 cloves of minced garlic

Sweet Paprika (at least 2 Tbsp.)
6 oz. of Sour cream (or more to taste)
1/4 cup of Flour

3 Tbsp. of Butter or olive oil to sauté the onions and garlic

the onions and garlic 1-2 Tbsp. butter to make the rue

Optional: chopped peppers and tomatoes (skinned/seeded), salt and pepper to taste

In a large skillet or Dutch oven, sauté the chopped onions with some olive oil or butter. Add 2 Tbsp. of paprika and continue to sauté. Add garlic when the onions are about half way done. Once onions and garlic are done, add the seasoned chicken on top of the cooked onions and garlic and cover mixing occasionally so the onions don't stick. Cook for 15-20 minutes. In the middle of the skillet, add about 1-2 Tbsp. of butter, once melted, stir in ¼ cup of flour to make a rue. (You may need more flour depending on how thick you like it). Add chicken broth and simmer to thicken. Add more paprika, salt, or pepper to taste. Turn the heat to low and add approximately 6 ounces of sour cream (more or less depending on your preference). Stir until mixed in and serve over homemade dumplings or egg noodles.

## **ANDREW HIRT**

Andrew M. (Drew) Hirt is the President of and Senior Scientist for Materials Research Laboratories, Inc. (MRL), specializing in experimental design, materials science research and development, failure analysis, and a number of other scientific endeavors. Drew is a product of the Catholic School system in Youngstown, having attended St. Matthias grade school and Cardinal Mooney High School. With a calling to science from an early age (5), Drew pursued his goal to become a scientist and received his B.S. degree in Physics from the Case Institute of Technology in 1977. He continued his education at Rutgers University in New Jersey, where he did graduate work in Materials Science. He also holds certifications in surface analysis and microscopy, having authored over fifty professional papers and books over the span of his 50 year career in science. His prior professional experience includes Technical Assistant for

the Case Institute of Technology (CIT), employment as a lab scientist for Perkin-Elmer, Physical Electronics Division and Laboratory Manager for Structure Probe, Inc. MRL was founded in New Jersey in 1988 and moved to Ohio in 1993 when many of the R&D centers located in New Jersey dispersed throughout the country. In addition to its efforts in analytical R&D and failure analysis, the company employs summer and part-time students, makes its facilities available to elementary, high school and college level students and works with several universities on publishable R&D projects.

Since moving to their laboratory to Struthers, Drew and his wife Carol Jean have assisted the Stuthers School system by participating in career days, judging science fairs, mentoring students in the middle and high schools and providing tours of their laboratory facilities. They also hosted overnight 'lock-ins' for students associated with local church youth groups for many years. Drew has assisted in the establishment of the STEM and entrepreneurship programs in the Struthers School system and has helped facilitate the formation of the Digital Media Arts and Robotics programs at the high school that include both coursework and participation in school system events and competitions.

Mr. Hirt has numerous professional affiliations and has been listed in "American Men and Women of Science" and "Madison's Who's Who of Professionals". Drew is involved in the American Physics Society (AVS/APS), the American Chemical Society (ACS), ASM International, the Catalysis Society and several other professional groups and actively participates in local, national and international meetings and symposia. Drew is married to his business partner, Carol Jean Hirt who specializes in electron microscopy. Drew and Carol work with several community groups including the Struthers Rotary (Drew is a former and current President), the Struthers School Foundation for Educational Excellence, the Chamber of Commerce and the CASTLO community improvement corporation. Their company (MRL) is involved with the internship programs with YSU and serves as a senior project mentor site for the Westminster College Chemistry Department. Drew is also currently an Adjunct Professor with the YSU chemistry department and

MRL has partnered with the STEM program on several of their recent instrument grant awards. He was recognized as the Outstanding Community Partner to the YSU STEM College at their 2016 Awards Banquet. Drew and Carol Jean have also served their Catholic parish as members of the Choir (Drew sings and plays guitar), Readers, Eucharistic Ministers and with the Catholic Marriage Preparation Program.

Drew spent 20 years assisting in providing meals at the Saint Matthias Annual Slovak Day. He has been active in FCSU Branch 682 over the last 30 years. In 2022, he attended and served as a Sargeant-at-Arms at the FCSU Convention. Currently President of Branch 682, Drew has filled that office since 2016 after serving several years as its Vice President. As President, he has promoted community involvement by providing food for the hungry though local programs, donations to rescue mission programs and scholarships to graduating Slovak high school students in the Struthers School System.

#### **RULES and REGULATIONS for the 2025 FCSU International Bowling Tournament**

- 1. The Tournament shall be conducted in compliance with the rules and regulations of the United States Bowling Congress (USBC).
- 2. This event is being sponsored by FCSU Financial® for the exclusive enjoyment of its members and their guests. The goal of the tournament is to promote fraternalism and good sportsmanship and generate interest in our Slovak fraternal organization. The National Officers of FCSU wish to extend a cordial invitation to all members and their guests.
- 3. **ELIGIBILITY:** This Tournament is open to all FCSU Members (age 18+) in good standing at the time of entry. Those with lapsed memberships/policies may not participate in the tournament or its related social functions.

\*Only bowlers paying the \$5.00 All-Events fee are eligible for the cash awards.

- 4c. The Prize Fees will be awarded 100% in each specific event. At least 1 in 10 participants in each event will win prizes. NOTE: Bowler may win only one cash prize per event (scratch or handicap), whichever cash prize is higher, excluding special prizes. Awards will be presented to the Bowlers who roll the highest scratch and handicap scores in each event.
- 5. SUBSTITUTES: Bowlers may compete only once in each event. No one may bowl in this tournament except those originally entered before the tournament opens or such substitutes who may be authorized by the captain of a team or his appointee, provided the individual whose name appears on the entry blank is unable for sufficient reason to attend the tournament at the time scheduled. - will use their highest sanctioned league average of at least 21 games as of March 15, 2025. Male bowlers who have no established average for this year or last year will be listed as having a **175 average** and will be handicapped accordingly.
- 8. **HANDICAP: Women's Division** will be calculated at 90% of the difference between 240 and last season's 2023-2024 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of March 15, 2025. Female bowlers who have no established average for this year or last year will be listed as having a **150 average** and will be handicapped accordingly.
- 9. FALSIFYING AVERAGES PENALTY: The team captain is responsible for reporting all averages of the individual team members. Should the Tournament Committee find at any time that the averages have been falsified, the team shall forfeit all claims for prize money as well as their entry fee and will be subject to disqualification and suspension from organized bowling. All prize winners are subject upon request to submit an affidavit of correct league averages.

- 12. Bowlers who participate in tournament games must be dressed in a presentable manner to appear before the public and when possible, to use an emblem attached to shirt or dress so that participant can be identified.
- 13. **FEE WILL NOT BE REFUNDED.** All prize fees will be paid in prizes.
- 14. In the Doubles Event, the names of both bowlers must be listed on the entry. Incomplete forms will be returned for information. If both entrants in the Doubles event appear when scheduled, it is understood that they must bowl as entered and no change in position will be allowed at any time after entry has been filed.
- 15. **LANE ASSIGNMENTS:** The Tournament Committee will assign lanes.




(Yuhas) Petrus, 96, of Donora PA, passed away

# News from Slovakia - Správy zo Slovenska

# **SPP began importing Russian gas through TurkStream**

Bratislava, February 6 (TASR) - From February 1 this year, the Slovak Gas Industry (SPP) began importing Russian gas to Slovakia via the TurkStream gas pipeline. From April, these deliveries should be doubled. This was said on Thursday at a meeting with journalists by the Chairman of the Board of Directors of SPP, Vojtech Ferencz.

Ferencz did not specify what the volumes would be. He reminded that SPP has a valid contract with Russia's Gazprom and the price for gas transit of this company is significantly lower than that of other suppliers.

Michal Ľalík, director of the SPP trade division, explained that despite this agreement, Slovakia will probably have to import gas through other routes, because the capacity of the gas pipeline through Hungary is not sufficient to cover the entire consumption. A route from Germany through the Czech Republic, where SPP has reserved capacity, is likely.

In January, SPP covered the needs of its customers mainly by pumping gas from a storage facility in which the company still has above-average gas reserves due to the current date.

Ferencz emphasized that ensuring sufficient gas supplies for customers is paramount for SPP. The problem is the rising price for gas and the higher price for supplies via alternative routes.

Gas prices are currently exceeding long-term highs and are at around €53 per megawatt hour (MWh). Back in December, before Ukrainian President Volodymyr Zelensky's announcement to stop any gas transit through Ukraine, they were at around 40 euros/MWh. Gas prices have risen at the current price after information about the gas shortage in Ukraine and the publication of a negative weather forecast for the coming weeks.

The price of gas on the stock exchange with delivery in the summer of this year, which is higher than the price of gas with delivery in the winter months, is also non-standard. This means that traders are worried about gas shortages in the summer, when EU countries have to fill storage facilities to meet the EC regulation on sufficient gas supplies at the beginning of the heating season.

# Pres. Pellegrini assured that no one wants to leave the European Union and NATO

Bratislava, February 4 (TASR) - President Peter Pellegrini assured that none of the coalition leaders or the chairman of the opposition KDH wants or is preparing the withdrawal of the Slovak Republic from the European Union (EU) and NATO. He therefore considers one of the main reasons for the regular demonstrations to be irrelevant. He said this after Tuesday's meeting with the chairmen of the coalition parties Smer-SD, Hlas-SD, SNS and the opposition KDH.

"It was very clear from this joint meeting of ours that no one, neither from the coalition parties nor the representative of the opposition KDH party, was interested in Slovakia's withdrawal from the European Union and NATO, no one is even planning such a withdrawal, no one is organizing and no one even assumes that Slovakia would see its future outside these two organizations," the president said. At the same time, according to him, everyone perceives the challenges and problems that the EU and the Alliance will have to face in the future. "Because we live in a very turbulent time. There are geopolitical shifts, there is a change in political systems," he outlined.

The president recalled that he convened the round table mainly at the request of the opposition parties KDH, PS and SaS, which expressed concern about the development of Slovakia's foreign policy. He was also led to this by the fact that fears of Slovakia's withdrawal from the EU or NATO are a motive for protesters at rallies. "If citizens continue to want to express their disagreement with something in this country, they have every right to do so, but it is useless if they express their disagreement with Slovakia's withdrawal from the EU or the North Atlantic Treaty Organization, because it is not true," he summed up.

He appreciated that the KDH leader attended the meeting. He considers the rejection of the invitation by PS leader Michal Šimečka and SaS chairman Branislav Gröhling as a sign of their immaturity and unreadiness to take over the country. He suspects them of wanting the continuation of the contradiction and questioning of foreign policy orientation.

The president endorses the idea of organizing further round tables on current challenges. "I will do everything to ensure that we once again find at least some basic consensus in the field of energy security of the country and in the field of foreign policy and speak the same language," he added. After the election of the Speaker of the National Council of the Slovak Republic, he wants to continue in the format of regular meetings of the three highest constitutional officials.

The meeting was attended by the leader of Smer-SD and Prime Minister Robert Fico, the chairman of the SNS and deputy speaker of parliament Andrej Danko, the chairman of the Voice-SD and Minister of the Interior Matúš Šutaj Eštok and the leader of the KDH and member of parliament Milan Majerský. PS and SaS rejected the president's invitation.

#### SPP začal dovážať ruský plyn cez TurkStream

Bratislava 6. februára (TASR) - Od 1. februára tohto roka začal Slovenský plynárenský priemysel (SPP) dovážať na Slovensko ruský plyn prostredníctvom plynovodu TurkStream. Od apríla by sa mali tieto dodávky zdvojnásobiť. Povedal to vo štvrtok na stretnutí s novinármi predseda predstavenstva SPP Vojtech Ferencz.

O aké objemy pôjde, Ferencz nespresnil. Pripomenul, že SPP má s ruským Gazpromom platnú zmluvu a cena za tranzit plynu tejto spoločnosti je výrazne nižšia ako u iných dodávateľov.

Riaditeľ divízie obchodu SPP Michal Ľalík priblížil, že napriek tejto dohode bude musieť Slovensko pravdepodobne dovážať plyn aj inými trasami, pretože kapacita plynovodu cez Maďarsko nepostačuje na pokrytie celej spotreby. Pravdepodobná je trasa z Nemecka cez Česko, kde má SPP zarezervovanú kapacitu.

V januári SPP pokrýval potreby svojich zákazníkov najmä čerpaním plynu zo zásobníka, v ktorom má podnik vzhľadom na aktuálny dátum ešte stále nadpriemerné zásoby plynu.

Ferencz zdôraznil, že pre SPP je prvoradé zabezpečenie dostatočných zásob a dodávok plynu pre zákazníkov. Problémom je rastúca cena za plyn a vyššia cena za dodávky alternatívnymi trasami.

Ceny plynu v súčasnosti prekračujú dlhodobé maximá a sú na úrovni okolo 53 eur za megawathodinu (MWh). Ešte v decembri, pred vyhlásením ukrajinského prezidenta Volodymyra Zelenského o zastavení akehokoľvek tranzitu plynu cez Ukrajinu, boli na úrovni okolo 40 eur/MWh. Na súčasnú cenu plyn zdražel po informáciách o nedostatku plynu na Ukrajine a zverejnení negatívnej predpovede počasia na najbližšie týždne.

Neštandardná je aj cena plynu na burze s dodaním v lete tohto roka, ktorá je vyššia ako cena plynu s dodaním v zimných mesiacoch. Znamená to, že obchodníci sa obávajú nedostatku plynu v lete, keď musia krajiny EÚ plniť zásobníky, aby splnili nariadenie EK o dostatočných zásobách plynu na začiatku vykurovacej sezóny.

# Prez. Pellegrini uistil, že nikto si neželá vystúpenie z Európskej únie a NATO

Bratislava 4. februára (TASR) - Prezident Peter Pellegrini ubezpečil, že nikto z koaličných lídrov ani predseda opozičného KDH si neželá ani nepripravuje vystúpenie Slovenskej republiky z Európskej únie (EÚ) a NATO. Jeden z hlavných dôvodov pravidelných demonštrácií považuje preto za irelevantný. Uviedol to po utorkovom stretnutí s predsedami koaličných strán SmerSD, Hlas-SD, SNS a opozičného KDH.

"Z tohto nášho spoločného stretnutia vyplynulo veľmi jasne, že nikto, ani z koaličných strán a ani predstaviteľ opozičnej strany KDH, nemal záujem o vystúpenie Slovenska z Európskej únie a NATO, nikto takéto vystúpenie ani nechystá, nikto neorganizuje a nikto ani nepredpokladá, že by Slovensko videlo svoju budúcnosť mimo týchto dvoch organizácií," vyhlásil prezident. Zároveň podľa neho všetci vnímajú výzvy a problémy, ktorým budú musieť EÚ a Aliancia v budúcnosti čeliť. "Pretože žijeme vo veľmi pohnutej dobe. Dochádza ku geopolitickým posunom, dochádza k zmene politických systémov," načrtol.

Prezident pripomenul, že okrúhly stôl zvolal najmä na žiadosť opozičných strán KDH, PS a SaS, ktoré vyjadrili znepokojenie z vývoja zahraničnej politiky SR. Viedlo ho k tomu aj to, že obavy z vystúpenia SR z EÚ alebo NATO sú motívom pre protestujúcich na zhromaždeniach. "Ak občania naďalej chcú vyjadrovať svoj nesúhlas s niečím v tejto krajine, majú na to plné právo, ale je zbytočné, ak vyjadrujú svoj nesúhlas s vystúpením Slovenska z EÚ alebo zo Severoatlantickej aliancie, lebo to nie je pravda," zhrnul.

Ocenil, že líder KDH sa na stretnutí zúčastnil. Odmietnutie pozvania zo strany lídra PS Michala Šimečku a predsedu SaS Branislava Gröhlinga považuje za prejav ich nevyzretosti a nepripravenosti prevziať riadenie krajiny. Podozrieva ich, že chcú pokračovanie rozporu a spochybňovania zahraničnopolitickej orientácie.

Prezident sa hlási k myšlienke organizovať ďalšie okrúhle stoly k aktuálnym výzvam. "Budem robiť všetko pre to, aby sme opäť v oblasti energetickej bezpečnosti krajiny a v oblasti zahraničnej politiky nachádzali aspoň aký-taký bazálny konsenzus a hovorili sme jedným jazykom," dodal. Po zvolení predsedu Národnej rady SR chce pokračovať aj vo formáte pravidelných stretnutí troch najvyšších ústavných činiteľov.

Na stretnutí sa zúčastnili líder Smeru-SD a premiér Robert Fico, predseda SNS a podpredseda parlamentu Andrej Danko, predseda Hlasu-SD a minister vnútra Matúš Šutaj Eštok a líder KDH a poslanec parlamentu Milan Majerský. PS a SaS odmietli pozvanie prezidenta. Líder PS Michal Šimečka označil formát stretnutia za pascu na opozíciu. Pripomenul, že o stretnutie ho žiadali tri opozičné strany, no hlava štátu pozvala aj koaličné strany. SaS odmietla byť súčasťou "falošnej hry" na nadstraníckosť, premiéra Fica nepovažuje za dôveryhodného partnera.
